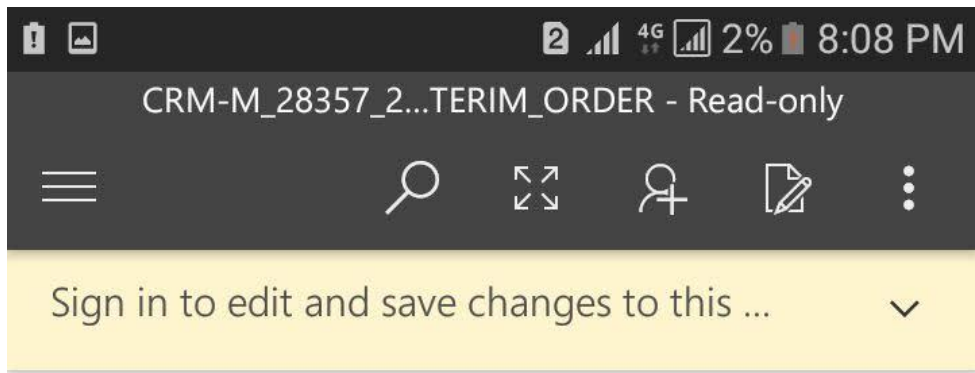

In the meantime, the matter be listed on 3rd October, 2017, on which date the petitioner, shall place a specific affidavit of undertaking explaining his Road Map to complete the project to honour his previous undertakings in terms of the earlier orders, and in cases where the original time for completion/delivery has already lapsed by over one year from the stipulated date in agreement, and the allottees are not inclined to accept any further delay, how and by which date shall he refund their outstanding dues.
